I, _____ the undersigned accept the financial responsibilities associated with this agreement from date of entry. I accept the annual fee increase that is applicable. I retain the right to terminate membership, knowing that I must notify the club in writing, one full term in advance upon doing so. One full term's notice in writing or one term's fees in lieu of notice is required when terminating membership.

To keep within the rules established by the South African Gymnastics Federation, I undertake to pay the Registration fee as determined yearly by the above mentioned organisation, such fee is due at the beginning of February each year, and is payable to the club, the club will register my child with the above mentioned organization. I am aware that the Registration fees, Tour fees, Official costs and Competition entry fees do not form part of the club fees.

The club retains the rights to terminate a gymnast's membership without a written warning in the case of theft or misbehavior.
